# Message from the President -

The country is experiencing planned cuts in social service and health care programs. Social Security recipients, particularly seniors nation-wide, are concerned their benefits may be targeted by the current Administration and if cuts or changes will affect the Social Security Fairness Act (SSFA). The SSFA was signed into law by President Biden on January 5, 2025 after passing in the House of Representatives in November 2024 and the Senate in December. 2024. The bill:

- eliminates the *government pension offset*, which reduces Social Security (SSA) benefits for spouses, widows, and widowers who also receive government pensions of their own.
- eliminates the *windfall elimination provision*, which reduces SSA benefits for individuals who also receive a pension or disability benefit from an employer that did not withhold Social Security taxes.
  - allows retirees to receive their full SSA benefit, even if they receive a public pension.

SSA began depositing retroactive payments in beneficiary accounts on 25 February, with most payments deposited by the end of March. Beneficiaries are asked to wait before inquiring about SSFA adjustments until after the receipt of their monthly benefit payment in April. Hopefully SSA benefits and SSFA adjustments will remain untouched.

## PACT Act and Your VA Benefits

The PACT Act was enacted to address the health concerns of Veterans exposed to toxic substances such as burn pits, Agent Orange and other environmental hazards. The Act outlines 23 presumptive conditions, meaning that if a Veteran has one of these conditions and was exposed to specific toxic substances during their service, the condition is presumed to be service connected. This presumption simplifies the process of claiming Veterans benefits by eliminating the need for Veterans to prove the direct connection between their service and their medical condition, easing the burden of proof typically required in disability claims. ### **Protecting Veterans from Romance Scams**

Romance scams targeting Veterans often begin innocently on dating apps or websites, social media platforms or even through email. Scammers create convincing personas and may pose as fellow Veterans, active duty military personnel, or individuals with shared interests and experiences. A scammer impersonating a deployed member of the military or a celebrity, gaining the Veteran's trust before eventually taking advantage of the romantic connection that has been created to request money. Some scammers will make plans to meet the Veteran or even propose marriage through messages. Trust your instincts: If something seems too good to be true or raises red flags, trust your gut feeling. If you encounter any suspicious behavior or believe you might be targeted by a scam, report it immediately. This includes notifying the platform where the interaction occurred and submitting a report to the FTC at ReportFraud.ftc.gov. For suspected VA benefits fraud, call the VA benefits hotline at 1-800-827-1000. For all non-Veteran Affairs related fraud, reach out to the Federal Trade Commission (FTC).
